Key Largo / Tavernier

Analysis of fiscal impact on County-wide services

This document represents a very cursory survey of the financial contribution to Monroe County by the communities of Key Largo and Tavernier. It also attempts to approximate the County resources spent in the two Upper Keys communities. Ocean Reef has been excluded from the analysis.

An accurate and thorough study would entail examination of detailed cost allocations and in-depth research. This would require many weeks to complete. This survey was completed to one day and as such, represents generalities which may or may not prove precise. The author cautions that this be kept in mind before reaching any conclusions based upon the attached findings.

The financial activity is presented in a combined overview sheet and also segmented in the corresponding County funds. The first attachment combines the activity without explanatory detail to give the general overview. The attachments following the first present each fund separately with detail on the assumptions utilized. Reviewing the assumption is important in evaluating the data.

Many revenue streams are collected by district and spent in the corresponding district. Thus, even though the dollar amounts are large, those activities are not included in this report. Examples include TDC activities, MSTU funds and Solid Waste collections.

Finally, some revenues are shared between the County and the various municipalities by statutory formula. In those cases, the Key Largo / Tavernier contribution figure is based upon approximations of these formulas.
