FKSPCA PROVIDES LOW-COST SPAY & NEUTER SERVICES FOR DOGS AND CATS AND THE OCCASIONAL EXOTIC PET. THE SERVICES ARE PROVIDED FREE OF CHARGE FOR PETS OF COMMUNITY RESIDENTS WHO ARE UNABLE TO PAY AND FOR ALL FERAL CATS AND ALL PIT BULL/PIT BULL MIXES. DURING 2016, FKSPCA SPAYED AND NEUTERED THE FOLLOWING ANIMALS: 380 CATS, 248 DOGS AND 25 RABBITS

THE VETS WHO WORK THE CLINIC PROVIDE THEIR SERVICES TO THE FKSPCA AT DEEPLY DISCOUNTED RATES. IN 2016, ALL OTHER CLINIC WORK WAS DONE BY VOLUNTEERS. IT IS ESTIMATED THAT OVER 3,500 HOURS OF CLINIC WORK ARE PERFORMED BY VOLUNTEERS.

THE KEY WEST DOG PARK WAS ESTABLISHED BY A SMALL GROUP OF KEY WEST CITIZENS AS A PROJECT OF THE FKSPCA. THE FKSPCA CONTINUES TO: (1) WORK AS LIAISON BETWEEN DOG PARK ADVOCATES AND LOCAL GOVERNMENTS AND (2) FACILITATE IMPROVEMENTS TO THE PARK. THE PARK PROVIDES A SAFE PLACE FOR THE DOG OWNERS OF THE LOWER KEYS TO BRING THEIR DOG FOR EXERCISE OFF LEASH AND A VENUE FOR ANIMAL RELATED EVENTS. EACH YEAR THE FKSPCA HOLDS AN ANNUAL EVENT AT THE KEY WEST DOG PARK FOR THE COMMUNITY AND THEIR PETS. THE EVENT PROVIDES A FUN VENUE FOR PET OWNERS TO GET INFORMATION ABOUT LOCAL VETS, PET SERVICES OF ALL KINDS AND THE FKSPCA SERVICES. IN 2016 SPONSORSHIP DONATIONS TO THE DOG PARK FUND WERE \$950 AND EXPENSES FOR THE DOG PARK WERE \$13.
